WPX Energy Rocky Mountain, LLC is requesting a CBL deferment on the Federal RU 33-7 located in the Section 7, T 7S-R93W. Attached is a temperature survey that was performed after cementing the 4 1/2" production casing on the subject well.

Please let me know if you need additional information to approve this deferment. After deferment is received, WPX Energy will continue to monitor the bradenhead pressure until the CBL has been performed and notify if pressure exceeds 150 psig.
