Thanks for providing the 2014 Annual Report. Please clarify the following:

- There are five (5) piezometers that were installed near or around the Facility please indicate on a diagram

the locations of these monitoring points. These monitoring points appear to be dry with the exception of a "trace" < 0.01 - 0.09 feet of moisture. Are these monitoring points requirements of the State Engineers Office or the COGCC? Should these monitoring points be properly abandoned? as they may be potential conduits for contaminants to enter into the subsurface.

- Attachment C provides monthly "Dam Inspections" with similar notes about rodent holes and erosion issues that appear on all of the monthly inspections. These issues shall be addressed upon discovery and reinspected after they have been addressed. These inspections shall be documented as part of the annual report.
- Does XTO provide monthly or annual reports to the State Engineers Office? If so, please include those reports in the annual submittal to the COGCC.
