Thank you all again for taking the time this morning to engage in what I feel was a very productive discussion. I really appreciate everyone's willingness to come to the table prepared to discuss and work toward a resolution. Also, thanks for your willingness to give this a little more time to have Eric and Jon discuss together.

Our system is unable to close the consult period at "close of business." The way the system works it closes it at midnight on any given day. However, if agreeable to all parties, COGCC will set the clock to close at the end of the day on 3/27/15 (i.e. at midnight, or 0:00, on 3/28/15) but will not consider any comment or recommendation made by CPW between 5:00 PM on Friday March 27, 2015 and 11:59:59 that night. In other words, CPW will have until close of business 3/27/15 to make their consultation comment based on their discussions with SG Interests in the intervening time.

COGCC remains committed to conducting our technical review of this Form 2A application between now and 3/27/15 also, so that at the conclusion of the consultation period, we may take action expeditiously on this permit.

Thanks again to all. And sorry this had to get so wordy.
