COMMENTS:

H&P 343 contracted for Noble Energy, found that the conductor on the McCaffrey State LD12-75-1BHN (Well 2 of 3) integrity left it unusable. This was the second well of the three well pad and therefore there is usable conductor 37.5' to the East. The McCaffrey State LD12-74-1AHN's (Well 3 of 3) conductor was plum bobbed and is planned to be used to drill the McCaffrey State LD12-75-1BHN (Well 2 of 3). Therefore the surface hole for the McCaffrey State LD12-74-1AHN (Well 3 of 3) will be moved to a new spot 37.5' E from where it was originally permitted. Speaking to Ms. Burn, a sundry needs to be sent on Monday, November 24th, for the abandoned conductor. This is the sundry abandoning the failed conductor casing for this well. We will take out the cellar ring, dig down an extra 6', fill the conductor w/ inert rock, cap the well, and finally fill in the hole.
