Backup Alarms, Jake Brakes, bulldozers, belly dumps, scraper, roller packer, bull dozer, scraper, belly dumps, roller packer  very brutal to wake up on a Friday morning at 6 am due to a bull dozer shining lights into my residence, back up alarms going full bore, and the tracks clanking away. No sound mitigation put in place at ALL!! Should be set to surface or "rat holed" by Wednesday the 18th of March. Ground is a dull rumble now due to the vibrator roller machine and can feel it in the kitchen of the residence. Operator never contacted me of the potential to drill at this location.
