





WELL LOCATION CERTIFICATE

In accordance with a request from Jay Knutson of EnCana Oil & Gas (USA) Inc., Washburn Land Surveying, LLC has determined the location of the **Regnier Farms 1F-19H-B268** well site to be SHL: 62' FNL and 1803' FEL, (TPZ: 770' FNL and 1395' FEL), (BHL: 460' FSL and 1375' FEL), as measured at ninety (90) degrees from the section lines of Section 19 Township 2 North, Range 68 West of the 6th Principal Meridian, Weld County Colorado.
