

W $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 13, Township 2 North, Range 68 West
E $\frac{1}{2}$ SE $\frac{1}{4}$ of Section 14, Township 2 North, Range 68 West
E $\frac{1}{2}$ NE $\frac{1}{4}$ and NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 23, Township 2 North, Range 68 West
W $\frac{1}{2}$ NW $\frac{1}{4}$ and NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 24, Township 2 North, Range 68 West
Containing 400 acres, more or less

Extraction is not the only owner within the Proposed Spacing Unit and has provided notice to the remaining owners, as required by COGCC Rule 318A.e.(5). Copies of the required notification letters are on file at Extraction's office. The required thirty (30) day notice period has elapsed absent the receipt by Extraction of any objection to their proposal by the owners within the Proposed Spacing Unit for the subject well.

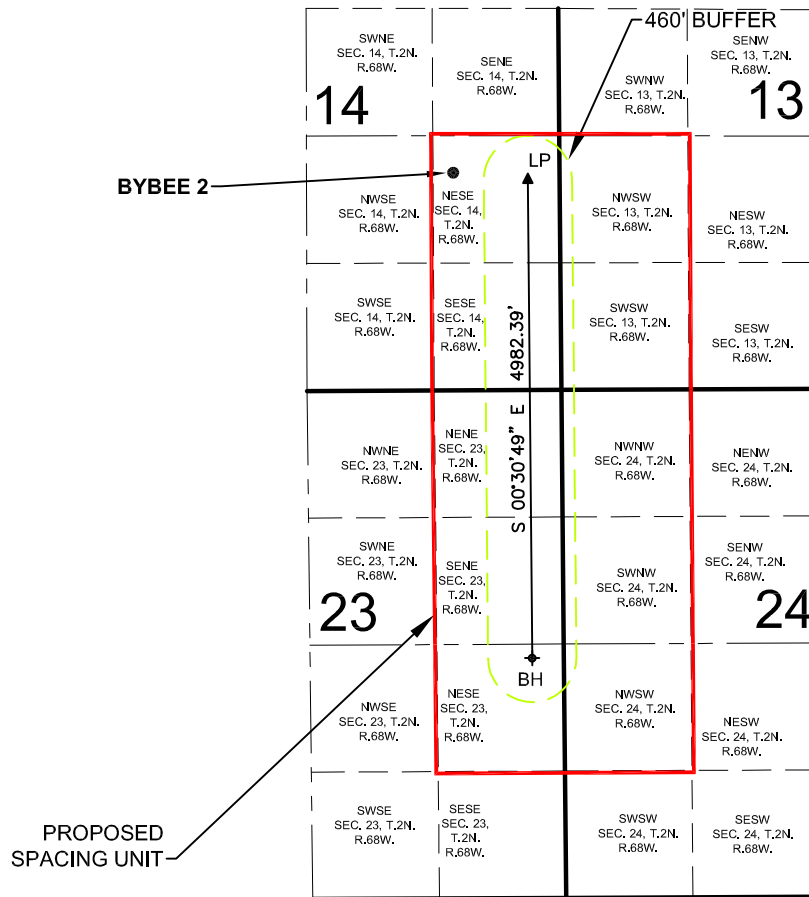

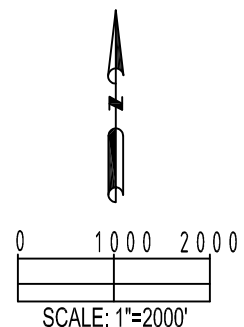
