Dear Mr. Regnier,


Encana Oil & Gas (USA) Inc. ("Encana") staked the above-mentioned wells at surface locations as indicated above and on the attached Well Location Certificates. These wells are being drilled under the rules and regulations of the Colorado Oil and Gas Conservation Commission's ("COGCC") Rule 603.a.(2) Statewide Location Requirements. This rule states:

- (2) A well shall be located not less than one hundred fifty (150) feet from a surface property line. The Director may grant an exception if it is not feasible for the Operator to meet this minimum distance requirement and a waiver is obtained from the offset Surface Owner(s). An exception request letter stating the reasons for the exception shall be submitted to the Director and accompanied by a signed waiver(s) from the offset Surface Owner(s). Such waiver shall be written and filed in the county clerk and recorder's office and with the Director.

The Regnier Farms 1A-19H-B268 through 1L-19H-B268 wells were staked at locations 62' south of your property line. As these locations were staked at your request and with your consent and approval, Encana respectfully requests your consent to an exception location for this well by waiver of the COGCC Rule 603.a.(2).


