In response to Inspection #666800570, for Location ID #334797, and in lieu of the requested form 42, Encana Oil & Gas (USA) Inc. has reviewed the associated corrective action: erosion on cut slopes on access road - provide adequate erosion control, stabilize cut slopes. In our review, it has been determined that the road mentioned in the inspection is a private road utilized by both the oil & gas industry and the private surface owner for multiple uses including oil & gas operations, dry land & irrigated pasture operations, agricultural, and various recreation activities.

The design and construction of this road occurred prior to the implementation of stormwater regulations in 2005; the road and cut slopes were designed within industry standards at the time of construction. Current road alignment and limits of disturbance would have to be modified to address cut slope concerns, and would require expanding the road boundary, ultimately increasing the surface disturbance in the area. Encana Oil & Gas (USA) Inc. will continue to inspect and monitor the road condition. Due to the private ownership of the road, all construction activities would be at the approval of the surface owner.

This road is associated with several other action required field inspection reports (see related forms). A sundry notice, doc. 400811949, was submitted in regards to Insp. doc. #666800567 to address a similiar corrective action item.
