Maintain BMPs" and will complete the work as soon as practicable while following best management practices described in our Wildlife Mitigation Plan, which is a formal agreement with Colorado Parks and Wildlife and provides guidelines to minimize the possibility of disturbing wildlife. Specifically, we will minimize our surface disturbance, recontoured slopes where possible, stabilize all areas not in use with vegetation, mulch, gravel or other methods, and maintain BMPs between July 31 and December 15.
