Dear Mr. Hansen,

Colorado Oil and Gas Conservation Commission Rule 305.a states:

For Oil and Gas Locations proposed within an Urban Mitigation Area or within the Buffer Zone Setback, an Operator shall provide a "Notice of intent to Conduct Oil and Gas Operations" to the persons specified herein not less than thirty (30) days prior to submitting a Form 2A, Oil and Gas Location Assessment, to the Director.

For the Buffer Zone Setback, those persons specified are the Surface Owner and any Building Unit Owners. The above listed wells are within 1,000 feet of your building unit(s), thereby placing them in the Buffer Zone Setback. Encana Oil and Gas (USA) Inc. respectfully requests your consent to an exception to the thirty (30) day notification requirement for the above mentioned wells with a signed waiver to COGCC Rule 305.a.


