COMMENTS:

A complete gas sample analysis is attached.

Gas was flared for 85 days during a 90 day period beginning July 23, 2014. The average flaring volume during this period was 141.24 MCF/D; volumes were measured daily. A pipeline connection was established on November 3, 2014 and gas has been flowing to sales. Frequency of flaring decreased and ended as the flowback and maintenance phase of the well was completed and a pipeline was established.

There is a presence of H2S; sampling showed 1ppm.
