ALL DISTURBED AREAS AFFECTED BY DRILLING OPERATIONS HAVE BEEN REGRADED AS NEARLY AS PRACTIBLE TO THEIR ORIGINAL CONDITIONS. THE SITE HAS BEEN REVIEWED TO DETERMINE WHAT PROCEDURES WILL OFFER THE BEST CHANCE AT REACHING REGROWTH GOALS, EXCEPT REASONABLY NEEDED AREAS FOR PRODUCTION. FACTORS THAT WERE CONSIDERED ARE PRE-EXISTING CONDITIONS, SOIL TYPE, SOIL COMPACTION, LAND OWNER PREFERENCE AND TIME OF YEAR. THE PHILLIPS MOIFIED DRYLAND PASTURE MIX WAS APPLIED USING A GRASS DRILL EQUIPPED TO SEED ALL TYPES OF GRASSES. ONCE APPLIED, A LAYER OF CERTIFIED WEED FREE STRAW WAS APPLIED TO THE SITE AT A RATE OF 3 TO 4 TONS PER ACRE AS NEEDED TO PROVIDE ADEQUATE COVERAGE. THE STRAW WAS THEN CRIMPED INTO THE SOIL TO GIVE THE SEED BED PROTECTION FROM WIND AND WATER EROSION.
