White 8-1 Proposed Procedure

- Pull tubing
- Rig up wireline and set CIBP above existing perforations
- Pressure test CSG to 1000 psi
- Perforate at 2500'
- RIH with tubing and cement retainer, set above perforations.
- Establish rate and attempt to circulate.
 - o If circulation cannot be established either squeeze with a volume based on rate or free point and evaluate casing patch possibility.
- Wait on cement, drill out.
 - o If squeeze job, might rig down before drill out and see if the backside gas has stopped before drill out.
