WPX Energy Rocky Mountain, LLC, the operator, (“WPX”) is seeking a permit to drill the following proposed Niobrara **horizontal** well to be located in Garfield County, Colorado:

GM 704-32-9-HMB2 (the “Well”)
Township 7 South, Range 96 West, 6th P.M.
Surface Location:
Section 4: NE/4NE/4 -- 701’ FNL and 916’ FEL
Bottom Hole Location:
Section 9: SW/4NE/4 -- 1981’ FNL and 1646’ FWL

WPX Energy Rocky Mountain, LLC has previously drilled the Niobrara **vertical** well with a surface location and bottom hole location described as follows:

GM 743-4 (the “Existing Well”)
Township 7 South, Range 96 West, 6th P.M.
Surface Location:
Section 4: NE/4SE/4 -- 1710’ FSL and 789’ FEL
Bottom Hole Location:
Section 4: NE/4SE/4 -- 1432’ FSL and 477’ FEL

See the map attached hereto as Exhibit “A” and made a part hereof, for the location of the Well and the Existing Well.

WPX proposes that a portion of the horizontal well bore of the Well be drilled closer than 1,200 feet to the existing vertical well bore of the GM 743-4. WPX proposes this variation so that micro-seismic surveys may be conducted with the two wells. The Existing Well will be used as the monitoring well during the fracture stimulation of the horizontal well bore. The micro-seismic surveys will gather data

that will help establish the proper well bore spacing for future horizontal wells in the Niobrara and Mancos. Companies providing micro-seismic surveys advise the two well bores be positioned close together to provide the best results for the survey.

The Colorado Oil and Gas Conservation Commission Rules and Regulations, Location of Wells number 318(a) states the following:

Wells 2,500 feet or greater in depth. A well to be drilled two thousand five hundred (2,500) feet or greater shall be located not less than six hundred (600) feet from any lease line, and shall be located not less than one thousand two hundred (1,200) feet from any other producible or drilling oil or gas well when drilling to the same common source of supply, unless authorized by order of the Commission upon hearing.

The Colorado Oil and Gas Conservation Commission Rules and Regulations, Location of Wells number 318(c) states the following:

Exception locations. The Director may grant an operator's request for a well location exception to the requirements of this rule or any order because of geologic, environmental, topographic or archaeological conditions, irregular sections, a surface owner request, or for other good cause shown provided that a waiver or consent signed by the lease owner toward whom the well location is proposed to be moved, agreeing that said well may be located at the point at which the operator proposes to drill the well and where correlative rights are protected. If the operator of the proposed well is also the operator of the drilling unit or unspaced offset lease toward which the well is proposed to be moved, waivers shall be obtained from the mineral interest owners under such lands. If waivers cannot be obtained from all parties and no party objects to the location, the operator may apply for a variance under Rule 502.b. If a party or parties object to a location and cannot reach an agreement, the operator may apply for a Commission hearing on the exception location.

The undersigned Offset Mineral Owners hereby waives any objection to the exception location of the above described Well pursuant to Rule 318(c) and grants permission to WPX to drill and produce from the Well at the above described location.


