If you are unable to contact Mr. Schneider at Anadarko today, we expect you to reach out to Mr. Morton (Chris forwarded his contact information) and any other affected individuals to see that their potable water needs are being met. I have been told that Anadarko was planning to discontinue potable water delivery but I do not know if that has happened yet.

Chris,

Thanks for taking the time to go over the NOAV yesterday with me before sending the document. I would like to confirm that the NOAV was received via email on Wednesday, February 25, 2015 and KPK immediately began working on the corrective actions upon receipt of the email.

After talking to you yesterday around 10:00 am, I immediately ordered the cement bond log with noise temperature logs and gas sampling analysis for each of the 4 wells listed on the NOAV. I also immediately ordered the MITs and started gathering all of the required workover, recompletion, remediation, and downhole work information from our physical records in the field and will send them to you as soon as I have them. Please confirm whether you want digital or hard copies. Additionally, I have also contacted the surface owner so we can sample the water well at issue immediately and continue to monitor it quarterly set forth in the NOAV. KPK has already coordinated quarterly monitoring events at the well. Further, I have also contacted Mr. Schneider at Anadarko in order to discuss the COGCC's request that KPK assume the responsibility to take over the water supply to the

surface owner. It is KPK's intent to supply the potable water during the evaluation and testing of the 4 wells, and any further supply of water will be contingent on the outcome of the evaluation and testing. KPK does maintain, however, that by supplying potable water to the surface owners, this does not result in any admission of liability or responsibility for any of the alleged groundwater contamination set forth in the NOAV or Complaint.

Finally, KPK would like to review a copy of the study performed (and any associated documentation used) which led to your conclusion set forth in the NOAV. Please let me know if I can stop by today to pick up the documents, or if you can email them to me.
