WPX Energy requests approval to add 1-300 BBL water tank to the RGU 23-6-297 pad. Please see attached exhibit showing where this tank would be located on pad. The purpose of this tank is to unload fluid from tubing off of the wells on this pad from time to time for well maintenance. Water dumps will not dump to this tank and fluids will only accumulate with well unloads. The tank will be installed in an earthen berm containment. Installation will begin as soon as approval is received and will be on location for the life of the wells. The tank will be painted Juniper Green.
