James,

On March 18th, 2015 CM Production met with the COGCC at the Spaulding Field. Alex Fischer and Kris Neidel were the COGCC inspectors. Mr. Fischer brought to our attention that we needed to build a berm around the smaller stock pile of treated soil. We used native soil to build the berm to his specification that was verbally explained to us. We dug a trench 2' in depth along the lease road on the west side of the pile and used the native soil from the trench to build the berm on the east side of the treated soil pile. On the South side of the treated pile we built the same type of berm with same specifications. No treated soil was used in the construction of the berm. This was done in the afternoon of March 18th, after the COGCC inspectors left the Spaulding Field. Pictures are attached. We have also pumped the oil sheen fluid from Pit #3 to Pit #2 and added oil absorbent booms, since the inspection. Last fall we had Pit #3, #4 and #5 drained and partially dried. After the winter, snow melt caused the pits to have fluid again. We are working on getting #4 and #5 completely drained (to Pit #2) again so the soil can dry out. All fluid from the pits will be in Pit #1 and #2. The aerator is running to help with evaporation in Pit #2. As the fluid level goes down we will continue adding fluid from Pit #1 to Pit #2 so all fluid is evaporate and all pits can dry out. If there is any other pictures, descriptions or actions that need to be taken please let us know.
