QEP requested to waive the corrective action on inspection number 667100281, to revegetate unused areas on well pad due to frequent maintenance requirements. COGCC reviewed request and a schedule of well maintenance from 2008 (in well file) and determined the well pad size was appropriate for the required level of maintenance at this well. COGCC reclamation specialist will conduct a followup inspection in 2015 to determine whether proposed stormwater and weed controls are sufficient and the location is stabilized.
