Description of Alleged Violation:
Field Inspection Report (Document # 663401123) for inspection on 8/22/2013 states that the well would not blow down thus indicating at least a tubing leak and therefore loss of mechanical integrity. Report required the following Corrective Actions: perform a successful MIT at least 1000 psi within 30 days (by 10/3/2013) or schedule the well to be plugged and abandoned. Follow up Field Inspection Report (Document # 667700556) for inspection on 2/12/2015 states that well had not been repaired and passed an MIT or been plugged and abandoned per the corrective actions specified in the 8/22/2013 Field Inspection Report.

Act, Order, Regulation, Permit Conditions Cited:
Rule 326

Dear Mr. Seale,

Enclosed you will find a Notice of Alleged Violation ("NOAV") issued to D. J. Simmons Inc for the Federal #33-8 well. During a routine Annual UIC Field Inspection (Colorado Oil and Gas Conservation Commission ("COGCC") Document # 663401123) on August 22, 2013 the well failed to blow down indicating a loss of mechanical integrity. Corrective Actions required by this Inspection Report included passing an MIT within 30 days (this implies the need from some type of repair) or arranging to plug and abandon the well. A second Field Inspection (COGCC Document # 667700556) conducted on February 12, 2015 indicates that the Federal #33-8 well has not been repaired and passed an MIT nor has it been plugged and abandoned. Also, COGCC records do not indicate that D. J. Simmons Inc has had the well repaired, got it to pass a recent MIT, or filed a Form 6-Notice of Intent to Abandon.

At the time of the inspection the Federal #33-8 was an Underground Injection Control ("UIC") Disposal Well , UIC Facility # 150401. Subsequently D. J. Simmons Inc requested that the well be removed from the injection program (Form-4 Sundry Notice Document # 400499879, approved 1/29/2014). Because all wells are required to maintain mechanical integrity whether part of an injection program or not, this NOAV is being issued because D. J. Simmons Inc has not repaired or plugged and abandoned within six (6) months of the discovery of the loss of integrity.
