## COMMENTS:

The purpose of this Form 4 is to sundry the re-use of treated E&P waste generated at the Clough 18 well pads (COGCC Facility # 335683). The treated E&P waste was generated during spill remediation activities. This beneficial re-use consists of using approximately 100 yards of treated E&P waste at the RMV 96-28 well pad (COGCC Facility #280753) to backfill an excavation left from spill remediation activities on the location (Spill tracking # 400808805). WPX received landowner approval to proceed with the transportation and re-use of the treated E&P waste. The laboratory results for the treated E&P waste are summarized in the attached table. The analytical laboratory reports are included as an attachment.
