### COMMENTS:

The pond was filled slowly beginning April 1 and continued on April 2 and 3, and was filled only during weekday, daylight hours. The pond was filled at a faster rate on April 6 and 7 and reached the 70% capacity at 4pm on April 7. The water level was 17.5' high. The water level and leak detection was checked every day. There was no water in the leak detection, and the pond level remained at 17.5'. The readings were the same when checked on April 13. The liner was not showing any leaks and the water level had not dropped – the hydro test was considered complete.
