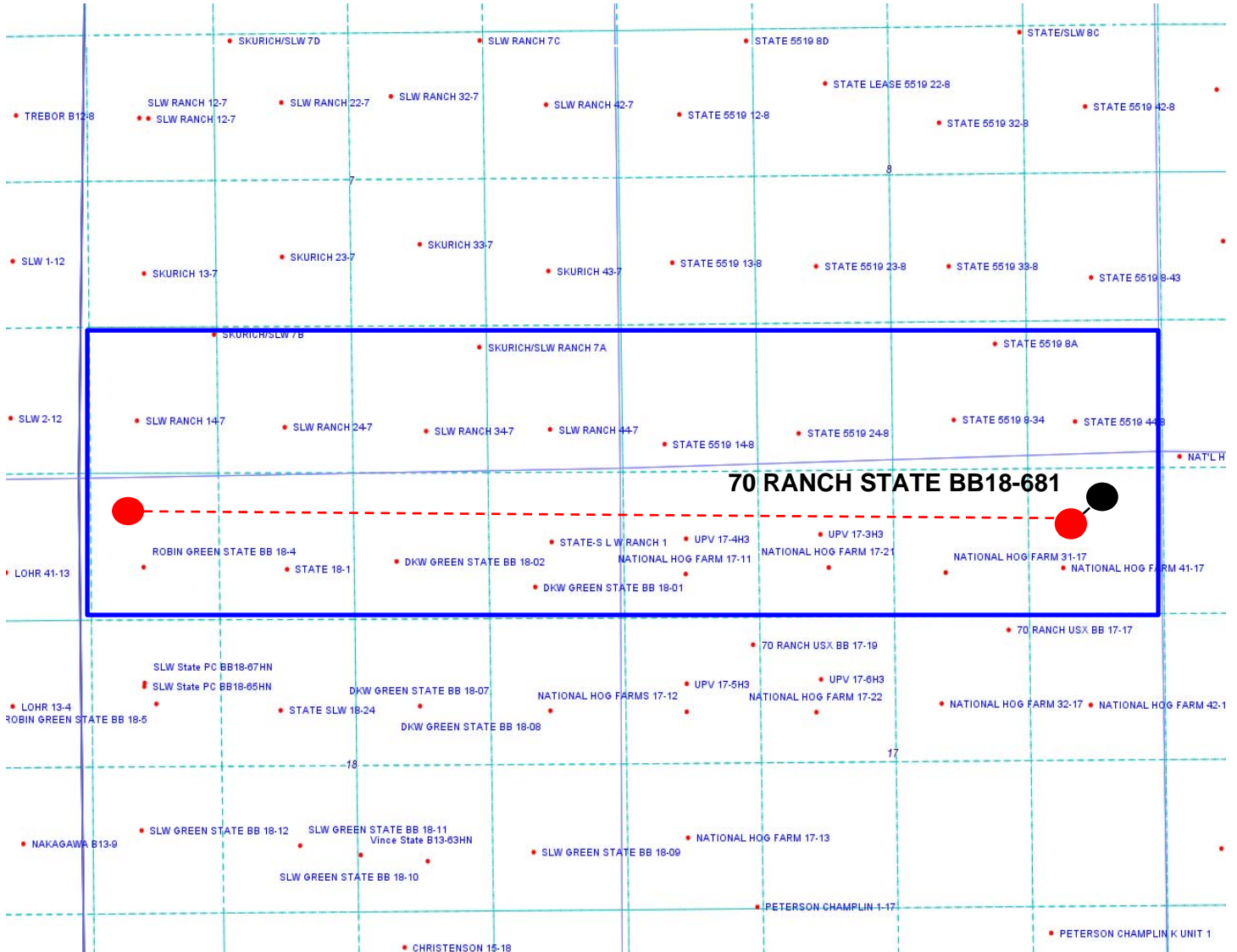

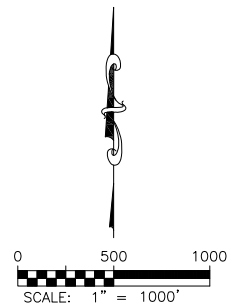
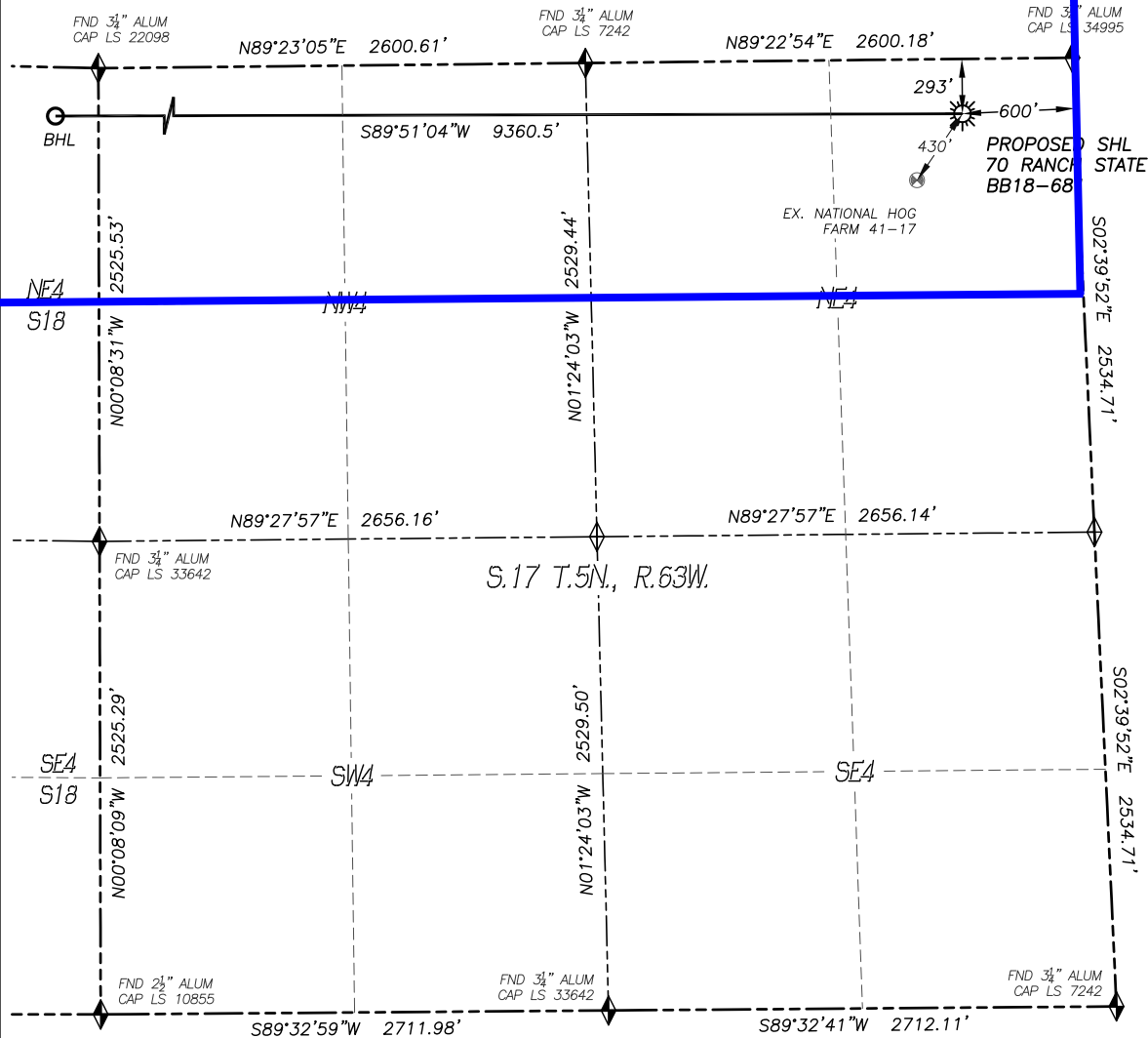
Bottom Hole Location

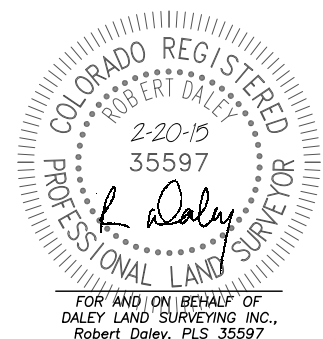

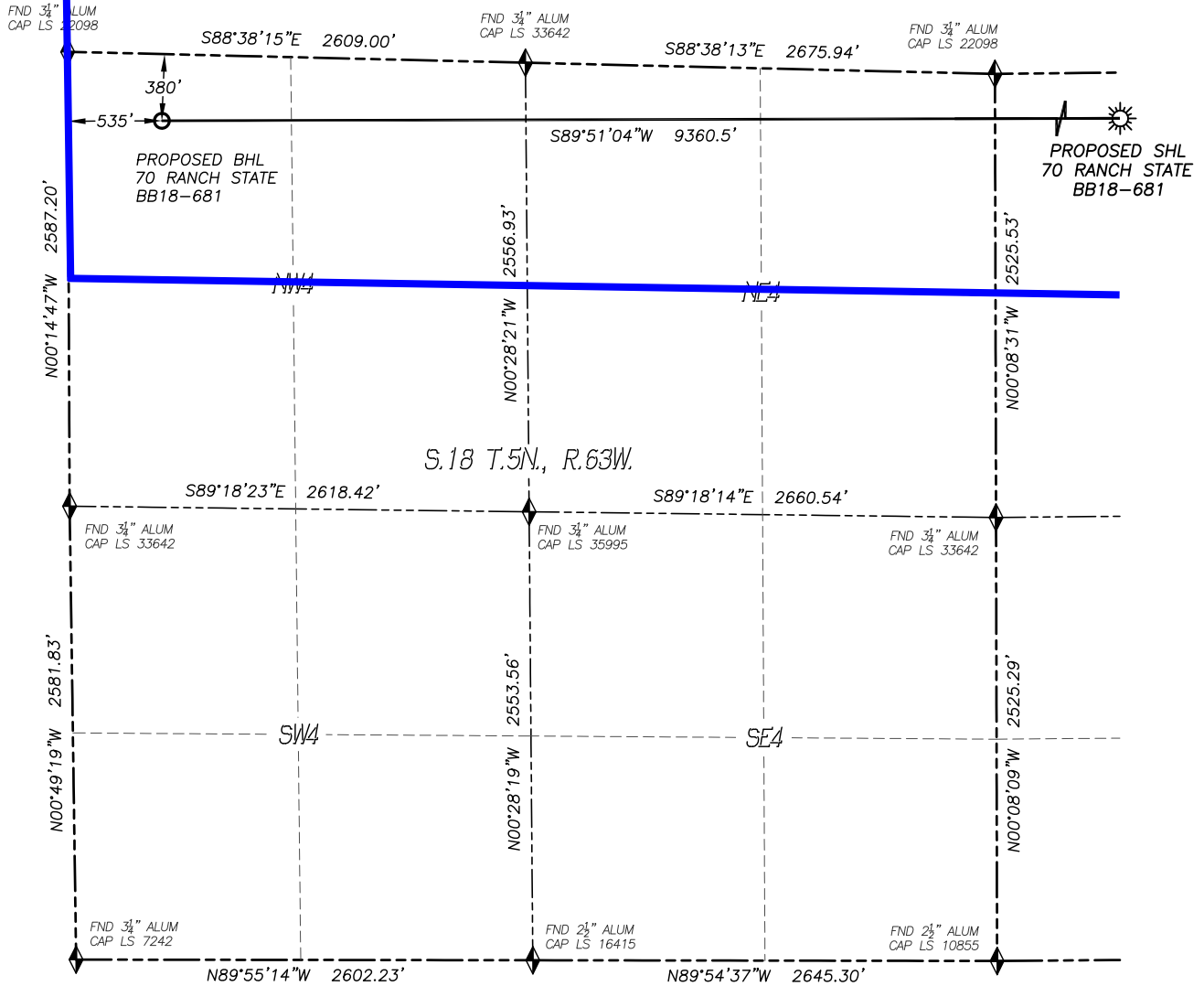
