This location is intended to be a receiving site for produced water transferred from OXY to Piceance Energy from various OXY locations within the Plateau Valley for completion operations being conducted by Piceance. The water will be transported by water truck from OXY produced water tanks on location via CR330 east to Harrison Creek, then south on Harrison Creek road to one of 2 COGCC approved temporary completion support locations which have 500 bbl "frac" tanks within the pad containment. The water will then be pumped from the water trucks directly into the "frac" tanks. The term of the agreement is for 6-12 months with an option to extend
