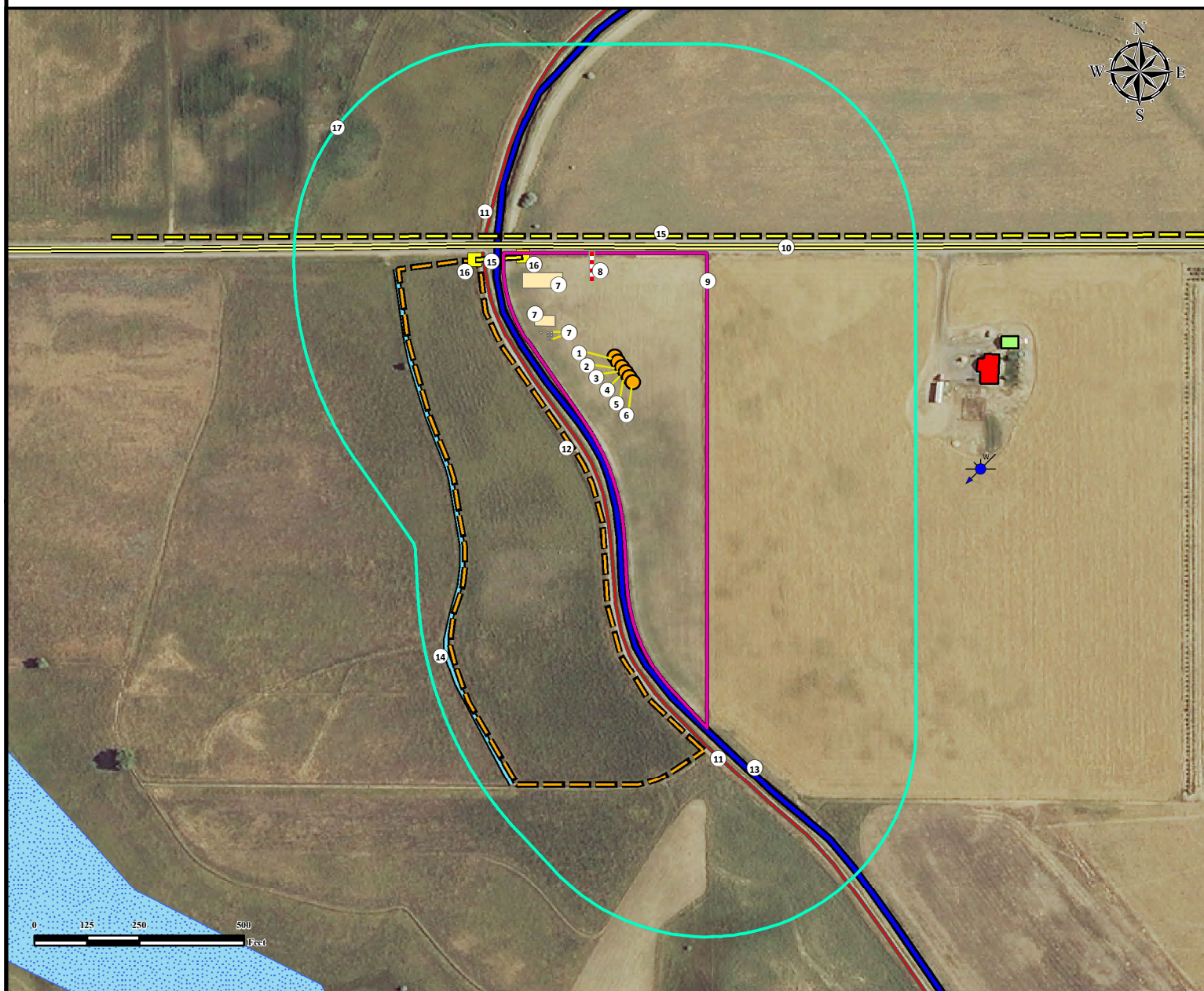


LONG 22-B PAD LOCATION DRAWING
