Piceance would like to set two 300 bbl tanks on this pad for water transfer. The purpose of these tanks is to allow for small water trucks to transfer produced water from our locations at higher elevations when the weather and roads are too dangerous for the larger transports. Once the small trucks off load at these tanks, we can then have the transports load out and haul the water off. Piceance originally had two "frac" tanks sitting on the location, but would like to set more permanent tanks with a containment ring.
