### COMMENTS:

Due to the drilling rig orientation contracted by Piceance Energy, this location requires a 25' width expansion on each side of the long axis. Most of the adjustment is taking place by adjusting the slope of the cut and fill of the pad. No significant change in the pad orientation or location is required. Additionally, the acces road was adjusted to improve grade and access to the pad.
