OXY USA Inc. (Oxy) is providing the COGCC with remediation status update for 2015 for the above referenced project.

2015 Proposed Activities:

The 2014 quarterly groundwater sample results indicate the continued transient presence of BTEX in the vicinity of monitoring well P15 and up-gradient of monitoring wells P9 and P10. Oxy believes there to be remaining impacted source material from the original Colorado Land #1 pit adjacent to P15. Historical document research on the COGCC database revealed information on a historical tank release that occurred in 1992 by then operator Fuel Resources Development Co. (Fuelco). Aerial imagery review from that time period shows what appears to be a single tank with containment located east-southeast of current monitoring well P9 (see attached Figure 1).

Oxy would like to excavate assessment holes in the vicinity of P15 and P9 to identify and delineate remaining subsurface impacted soil. The anticipated depth should be approximately 12 feet below ground surface, yet just above expected groundwater. The soils will be field screened with a photoionization detector and sampled for the hydrocarbon portion of the COGCC Table 910-1 analytical list. Investigation results and remediation plans will be submitted with a Form 4 update.
