COMMENTS:

As per Kerr McGee Oil and Gas Onshore LP's (Kerr-McGee) approved Waste Management Plan for Land Application of Water-Based Bentonitic Drilling Fluids & Associated Drill Cuttings, the drill cuttings from the Vonderlage 29N-W31HZ and Vonderlage 30N-W31HZ wells were land applied to the surface of the Vonderlage 29N-W31HZ well pad. The drill cuttings from the wells were mixed with EcoSponge bioremediation product and incorporated into the native soil during well pad reclamation activities. After final incorporation, a four-point composite soil sample (Pad Comp) was collected from 0-8 inches below ground surface (bgs) from the reclaimed well pad and submitted for laboratory analysis of total petroleum hydrocarbons (TPH), benzene, toluene, ethylbenzene, and total xylenes (BTEX), pH, electrical conductivity (EC), sodium adsorption ratio (SAR), total arsenic, and total barium. Four discrete background soil samples (Off S, Off E, Off N, and Off W) were collected from the undisturbed native surface soil surrounding the well pad and submitted for laboratory analysis of total arsenic. The four background samples were also composited into one additional soil sample (Off Comp) and submitted for laboratory analysis of pH, EC, SAR, total arsenic, and total barium. Laboratory results confirm that all concentrations and levels in the Pad Comp sample were compliant with the Colorado Oil and Gas Conservation Commission (COGCC) allowable levels (Table 910-1) and/or below the site background levels. Based on the laboratory results, Kerr-McGee is requesting a no further action (NFA) status for this well pad. The laboratory report is included as an attachment to this Form 4.
