**COMMENTS:**

This COGCC Form 4 is being submitted as a request to meet the background concentration levels for arsenic at the PA 13-32 well pad in accordance with footnote 1 to the COGCC table 910-1. The request is based on the analytical results presented below (see attached laboratory reports).

Two composite samples were collected from the cuttings management area to determine the arsenic concentration in the cuttings. One composite sample was collected from the cuttings generated during drilling activities of the vertical section of the well and one composite sample was collected from the horizontal section.

PA 13-32 cuttings (vertical) – 2.3 mg/kg  
 PA 13-32 cuttings (horizontal) - <10 mg/kg

Three grab samples were collected from nearby non-impacted, native soil to establish the background arsenic concentrations.

PA 13-32-B-1 – 10 mg/kg  
 PA 13-32-B-2 – 9.5 mg/kg  
 PA 13-32-B-3 – 8.1 mg/kg

WPX Energy is requesting this approval in order to proceed with closure and reclamation of the PA 13-32 cuttings management area.
