COMMENTS:

XTO Energy has found a casing integrity issue with this UIC well. XTO intends to repair the casing leak and then place the well in a TA Status per the attached procedure & wellbore diagrams. We are currently waiting on a rig to become available.

Please note the next 5yr UIC MIT is due 05/13/2015 but given the casing issue it will not pass, therefore XTO will run the MIT after we have successfully repaired the casing.

After the repair work is completed XTO is requesting a TA Status because there is currently no pipeline to deliver produced water to this UIC well for injection. We are in the process of investigating existing infrastructure in the area in order to tie this well into our disposal system.
