WPXENERGY had multiple unused conductors on the KP 22-16 pad. The following work was completed.

Cellar rings were removed and hauled off. Conductors were cut off 4' below ground level and back filled with inert spoils from the well pad. A 4 ft cement cap using Ready Mix cement was installed and followed by welding on of a steel plate. Cellar was backfilled with spoils from the pad back to pad grade. Cmt tickets are attached.
