COMMENTS:

This form is being submitted as a status update for a Remediation Project (8865) and in response to a COGCC Inspection (674300227) corrective action requesting completion of remediation system installation in support of final reclamation efforts on the Park Mountain Federal 9030 well pad (316198) in the Rangely area of operations (Park Mountain Field).

While conducting a site investigation in support of final reclamation efforts in December, 2014, impacted soil from a historic release was identified near the removed tank battery and was documented in a Form 19 - Spill / Release Report (400763670).

Between April 2 and 7, 2015 a soil auger rig advanced 17 soil borings at the location to identify vertical and lateral extent of impacts and install an in-situ remediation system. Based on field screening with a hydrocarbon test kit and laboratory results, one (1) soil boring locations identified soil with elevated hydrocarbon concentrations. Six (6) soil boring sites were converted to soil vapor extraction (SVE) wells, which will be capped with wind-powered ventilator turbines. Soil boring and well installation efforts are detailed in the attached report from the environmental contractor. The installed wells and turbines will receive regular visits for operations and maintenance (O&M). A report of findings from O&M data collection will be provided to the COGCC and BLM in 2016 with recommendations on how to proceed with the project.

The site will be fenced to support reclamation efforts and protect the installed wells from damage.
