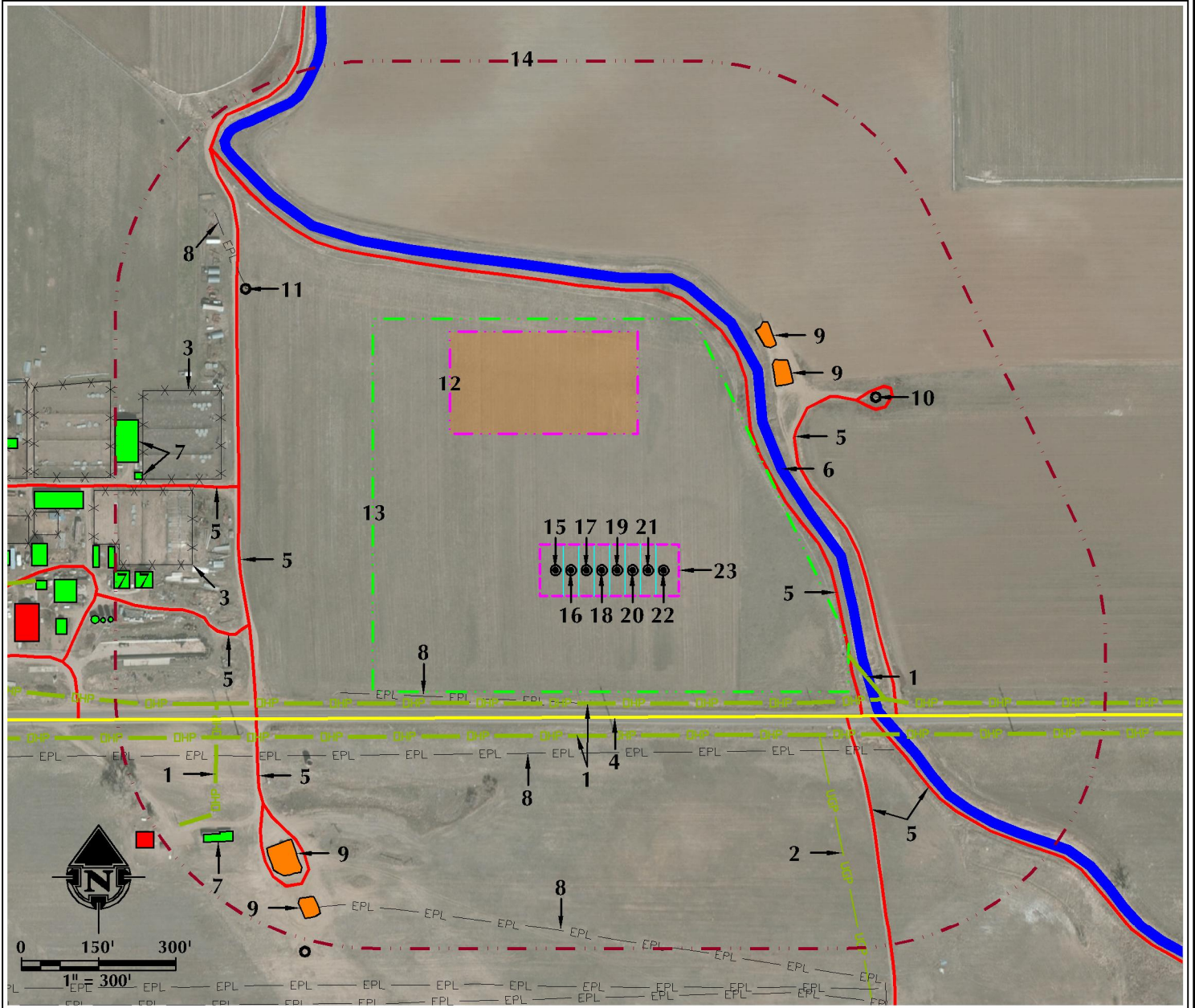


# LOCATION DRAWING TEDFORD 29C-28HZ HORIZONTAL MULTI-WELL PAD
