Chevron is seeking approval for a packer depth reset. UP113x22 is a producing well, Chevron plans to Temp Abandon at this time. The perforation interval is 6295-6630', the wellsite engineer ran a packer and could not get the casing to test from 6170-6295'. a lower packer was set at 6159' and tested good. A second packer was set at 6135 using 2-6' pups and the on/off tool to keep the packer as low as possible.
