COMMENTS:

The completions team was conducting frac operations and recorded a bradenhead pressure of 50 psi at the beginning of the 3rd treatment interval on 5/18/15. The pressure was gradually built up during the frac to 544 psi and was bled off and about 2 gal of fluid was recovered. At the beginning of the 4th treatment interval on 5/18/15 the pressure was 77 psi and was bled to 0 psi and about 1 pint of fluid was recovered. During the frac the pressure built up to 221 psi, but then it decreased to 52 psi as the frac job progressed. After that frac stage the pressure was bled off to 0 psi and about 1 pint of fluid was recovered. It is believed the pressure build up was the result of the frac pressure expanding the casing which caused the pressure to increase on the backside. As the frac pressure decreased, the bradenhead pressure decreased as well. The bradenhead pressure will be monitored closely and no mitigation is planned at this time.
