OPERATOR COMMENTS AND SUBMITTAL

Comments The current plan is to run all production from these wells to the Pronghorn CPF A-15 facility. Once this facility is connected up, the east side of the existing P-16 Pad will be reclaimed. However, if economic conditions warrant the reduction of new construction, facilities located on this pad will be augmented instead of removed. Therefore, we have included all facility equipment for that case in the "Facilities" section of this permit. It is not the intention of Bonanza Creek to build the full amount of permitted equipment on all locations, rather it is the desire to minimize disturbance and optimize our operations to ensure excellent stewardship that we are requesting this flexibility. If we were to run production to the CPF, the equipment on the location would include the following: 7 Pumpjacks, 7 gas or diesel motors, 2 oil tanks, 10 separators, 8 electric motors, 2 VOC combustors, 2 water tanks, 4 cavity pumps, 1 flare, 2 water vaults, 4 pigging stations.

The final equipment listing for this location will be reported to the COGCC on a sundry to accurately reflect as-built conditions at the time interim reclamation is completed.

1	Construction	The following procedure describes BCEOC standard construction practices for setting a partially buried pre-cast cement water vault and new tank battery construction. 1) The excavation will first be lined with 4" of clay or other low permeability soil. 2) A 30 mil liner will be installed on top of the low permeability soil. The 30 mil liner will be a contiguous liner which will underlay the entire tank battery. 3) The tank battery / water vault liner will be keyed into a galvanized steel containment ring installed surrounding the tank battery. 4) Sand bedding will be installed to protect the synthetic liner prior to placing equipment in the containment area.
