Chevron Midcontinent is working with the City of Durango on the Wilson Gulch pipeline project. Chevron Midcontinent would like to temporarily install 3-400bbl water storage tanks at the Crader 3-2 location and route produced water from the following wells: Federal 3-1, Federal 4-1, Montoya 10-2, and Crader 3-2. Proper secondary containment (per MCBU requirements) will be installed as well as SCADA in place on the tanks with a call-out. This will minimize down production due to the City of Durango's Wilson Gulch roadway project. This will also reduce risk of the City's contractors potentially hitting a live Chevron Midcontinent pipeline.
