Encana Oil & Gas (USA) Inc. completed well repair operations on the subject well 03/02/2015 per the approved procedures documented in sundry notice document #400794053.

The well was repaired as follows:

1. Retrievable bridge plug set at 2,470' and conduct pressure test – failed test
2. Plug and packer tests, 2 leaks isolated from 2,363' – 2,428' and 2,470' - 2,480'
3. Trip in hole with mechanical cutter, cut casing at 2,580'
4. Tag and patch casing at 2,581'. Pressure test casing to 1,000 psi. Held for 5 minutes. Install B-section of casing. Pressure test to 5,000 psi, held.
5. Pressure test casing to 1,000 psi. Held good for 15 minutes.
6. Retrieve bridge plug and land tubing
7. Repair operations completed & well returned to production
