| On May 29, 2015 COGCC SW EPS Jim Hughes conducted an environmental field inspection of the COGCC South Fork Texas Creek MW 35-7-8 #1 and #2. This location consists of two well heads covered with locked steel and expanded metal cages and one locked metal building housing the telemetry and data logger equipment. There is no remaining surface evidence of a pad or access road. The location signs are inside the protective cages for each well. There is no emergency contact information listed. An additional sign, with this information and the location of the nearest intersection, shall be prepared and hung near the location signs. This site is historically visited 1-2 times per year to download pressure transducer data and inspect the well heads for any problems. | hughesj | 06/03/2015 |
