


WELL LOCATION CERTIFICATE: SARCHET 36N-20HZ

- GRID DISTANCES ARE SHOWN, AS MEASURED IN THE FIELD, WITH TIES TO WELLS MEASURED PERPENDICULAR TO SECTION LINES. TO GET GROUND DISTANCES MULTIPLY THE SHOWN DISTANCE BY 1.000272228.


