This area is where the old skim pit was located. The pit was excavated, contaminated soil was disposed of in an approved waste dump, and the pit was backfilled as per instructed in AOC No. IV-435 and a Form 4 Sundry Notice was submitted and approved by the COGCC for completing this work. (Document # 400792626, approved 03/30/2015). This area and the area between the produced water pit and the tank battery will be seeded and fenced to establish additional rangeland grasses as soon as recent rains will permit.
