In advance of our meeting tomorrow, I am providing to all those that I believe will be attending a breakdown of various cost categories of expenditures made by CM at the Lone Pine site in 2014. I believe that some of this information may have been provided to the State previously, but I wanted to capture same in a single email to facilitate discussion tomorrow. The attachments summarize 2014 expenditures thru late in the year; they are not fully complete (especially for the last quarter) but do provide a narrative regarding work done thru the year.

The attachment below is from CM's consultant James Hix, and describes all work done by his firm at Lone Pine with individual invoice amounts since starting work on the project. Note that I have not provided a breakdown of my own legal fees for Site environmental and remediation activities that support some of these tasks, but can discuss same as necessary tomorrow.

I am providing this information for two purposes: (1) to frame part of what I understand will be the discussion tomorrow, regarding the amount expended in 2014 on pit decommissioning and attendant tasks; and (2) to provide a better sense to meeting attendees of the overall scope of the ongoing work being performed at the site and the efforts being made overall to address items contained in the various decrees, all of which I expect to be part of the discussion tomorrow as well.

I have previously sent to Peter various reports and updates that were submitted to support the proposed consent decree now pending between OGCC and CM, but will bring same along to the meeting as well.

We look forward to tomorrow's meeting, note that as indicated to Peter today, John Teff is traveling and will participate by phone. Regards, Roger
