Re: Directional Drilling on SE/4 Section 7-T5N-R67W, Weld County Colorado

Dear Members of the Zeiler Family:

Kerr-McGee Rocky Mountain Corporation ("KMRMC") holds oil and gas leases under the above-captioned property, on which Zeiler Farms, Inc., ("Zeiler") is the surface owner. KMRMC recently sought and received a permit from the Colorado Oil and Gas Conservation Commission ("COGCC") to drill the KMRMC Zeiler Farms 15-7 well vertically in the SW/4 SE/4 Section 7, T5N R67W. On August 18, 2005, representatives of KMRMC and Zeiler had held surface consultations for the Zeiler Farms 15-7 well as required under COGCC rules. KMRMC's mineral rights and the issuance of the COGCC permit give KMRMC the right to drill the Zeiler Farms 15-7 well on the permitted location, with accompanying reasonable rights of ingress and egress to develop its property.

Subsequent to COGCC's issuance of the Zeiler Farms 15-7 well permit, Zeiler representatives filed two protests with the COGCC, one on the 15-7 well permit and one on the 16-7 well permit, which has not been issued yet. Zeiler representatives sought an additional consultation with KMRMC, and requested that KMRMC change the location of the Zeiler Farms 15-7 well. Zeiler representatives proposed that KMRMC drill that well and two others, the 10-7 and the 16-7 wells, directionally from an area that the Zeiler representatives designated.

James P. Wason, Dirk Baysinger, Duane Haley and Alvin Kirkpatrick of KMRMC and Kathleen Weinmeister, Ken Zeiler & Rich Zeiler of Zeiler Farms, Inc. discussed this proposal at a second onsite meeting held on October 25, 2005. The parties reached general agreement on the Zeiler representatives' preferred location, and on the conditions that would have to be satisfied for KMRMC to restrict itself to directional drilling in the designated area. Following is a summary of those terms.

Zeiler requests that KMRMC restrict its operations to a designated Oil and Gas Operations ("OGO") area generally described as the strip of land south of the Great Western Railway Company tracks and north of the BCL Ditch, and drill the 15-7, 10-7 and 16-7 wells directionally from that location. Zeiler proposes that KMRMC access the OGO area by crossing the BCL Ditch with the installation of a culvert and constructing a bridge for the purpose of accessing this location. Zeiler requests that KMRMC place its surface equipment (wellheads, treaters, separators, tanks and meter houses) in the OGO area, and place its gathering lines in or adjacent to the access right of way.

KMRMC is willing to accommodate Zeiler's request, subject to the following conditions.

Zeiler will compensate KMRMC for the \$250,000 incremental cost of drilling the three wells directionally. The incremental directional drilling costs will be placed in escrow until the wells are actually drilled. Zeiler will assist KMRMC in obtaining needed waivers from the BCL Ditch, the Great Western Railway Company, and Ms. Sorenson, the owner of the property adjacent to the OGO area. KMRMC cannot drill in the OGO area without all three waivers. Zeiler Farms will assist KMRMC in obtaining a ditch crossing agreement from BCL Ditch, under terms acceptable to KMRMC.

In addition, the parties will execute a recordable Surface Use and Directional Drilling Agreement, with Exhibits describing with particularity the OGO areas, access routes, flowlines and gathering lines. Zeiler's will waive any rights to surface damages.

When all of these conditions have been satisfied and the parties have executed mutually satisfactory agreements as described above, and KMRMC is assured that it can gain access to and drill from the proposed OGO area, then KMRMC will move to amend its permit for the Zeiler Farms 15-7 vertical well, and ask the COGCC for approval of a directional drilling location for the 15-17 well, the 10-7 well and the 16-7 well.

Time is of the essence in this arrangement. Therefore, all payments, third party agreements and waivers must be in hand, and the Surface Use and Directional Drilling Agreement executed, no later than November 18, 2005.
