ECGS 6-18 D011-2 has been functioning injection-withdrawal gas storage well since October 14, 2012. Reservoir modeling indicates increased flow performance can be achieved if additional Dakota D interval is perforated. East Cheyenne Gas Storage, LLC plans on perforating an additional 10 feet of interval in the Dakota D Formation. Existing perforations are 5179 - 5190 feet. New perforations would add 10 feet from 5190 - 5200 feet. New perforated interval will be from 5179 - 5200 feet. A post work wellbore diagram has been attached.
