Rich,

As we discussed this a.m. I have attached photos taken on March 10, 2015 from the Grizzly 3-32H (API 057-06523) location. An Inspection report is forthcoming, but I wanted to inform you that the pooled liquids (snow melt and oil) need to be removed from location immediately and properly disposed. Please have your crews inspect this and other locations with the upcoming snow melt and remove any fluid (water or oil) upon discovery. Also, I meant to mention to you that there is significant oil spillage/release(s) inside of the "pump house". This needs to be addressed and the COGCC is requesting that EE3 submit an eForm 19 Spill Report as relates to the "pump house."
