In order to close the facility ID associated with the pit, the COGCC requested Noble provide a status update on field conditions. Field visits were conducted and photographs were taken to document the conditions of the pit. Based on the information provided, the pit appears to have been reclaimed in accordance with COGCC rule 1004 b. and there is no indication that an investigation or remediation activities are required for the site. Noble requests a change to close the former pit associated with the ARAPAHOE-61N69W /36NWNW (321279) facility.
