## COMMENTS:

This COGCC Form 4 is being submitted as a request to meet the background concentration levels for arsenic at the BCU 33-30-198 well pad in accordance with footnote 1 to the COGCC table 910-1. The request is based on the analytical results presented below (see attached laboratory reports).  
One composite sample was collected from the cuttings management area to determine the arsenic concentration in the cuttings.  
AP 21-20-695 cuttings – 12 mg/kg  
Three grab samples were collected from nearby non-impacted, native soil to establish the background arsenic concentrations.  
AP 21-20-695-B-1 – 180 mg/kg  
AP 21-20-695-B-2 – 31 mg/kg  
AP 21-20-695-3 – 31 mg/kg  
WPX Energy is requesting this approval in order to proceed with closure and reclamation of the AP 21-20-695 cuttings management area.
