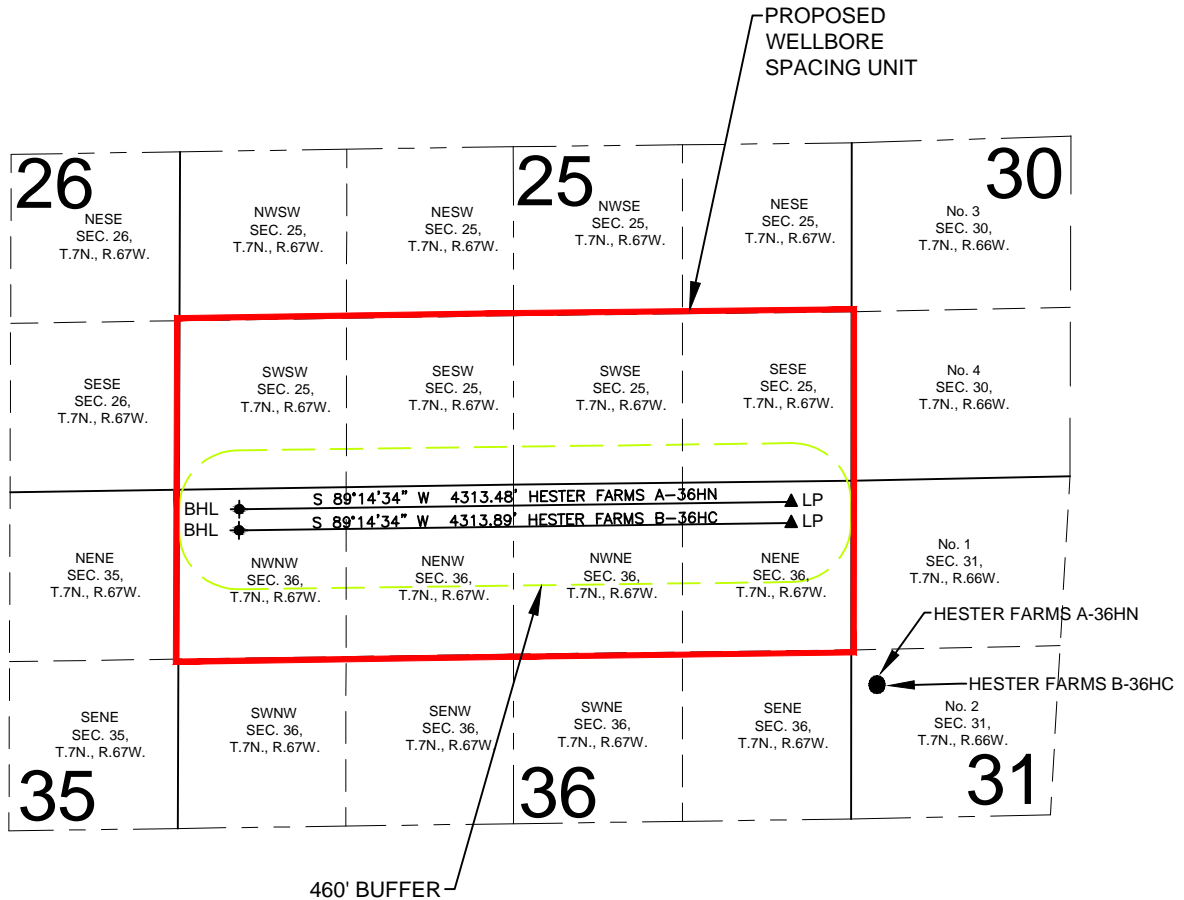

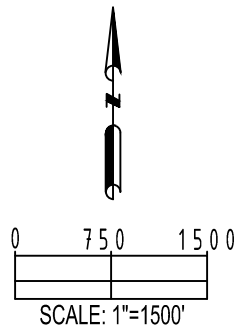
**HESTER FARMS 31-H PAD**
