#### COMMENTS:

A complete gas sample analysis is attached.

Gas was flared for 22 days during a 30 day period beginning November 12, 2014. The average flaring volume during this period was 351 MCF/D; volumes were measured daily. A pipeline connection was established on November 19, 2014 and gas has been flowing to sales. Frequency of flaring decreased as the flowback and maintenance phase of the well was completed.

There is a presence of H2S; sampling showed 0.25ppm.
